2. Chair and composition of 2010-2014 Membership Committee nominees

 - The clinical representative from North America who was originally recommended could not serve so an alternate will be identified.
3. Chair of 2010-2014 Nomenclature Committee (NC-IUPHAR) nominee: Michael Spedding, France
4. It was recommended that the ASPET-IUPHAR agreement for publication of NC-IUPHAR articles which expires in October 2011 be renewed.
5. It was recommended that a mentoring program for IUPHAR societies be considered.
6. It was recommended that the current composition of roles on the Executive Committee be retained.
7. It was recommended that the four-year cycle of IUPHAR meetings be evaluated. While everyone agreed it was desirable to combine basic and clinical pharmacology into a single World Congress, there were concerns about allowing four years to pass between IUPHAR-sponsored meetings.

It was agreed that all articles bearing the name of IUPHAR would require approval by the Executive Committee or officers in advance of publication. The 2010-2014 Executive Committee unanimously approved that IUPHAR endorsement be displayed on an article entitled “Clinical Pharmacology in Research, Teaching, and Health Care” authored by Donald Birkett, Kim Brøsen, Ingolf Cascorbi, Lars L. Gustafsson, Simon Maxwell, Lembit Rägo, Michael Rawlins, Marcus Reidenberg, Folke Sjöqvist, Tony Smith, Petra Thürmann, and Andrew Walubo. This report,

Dr. Vanhoutte recommended that the new publication be circulated among the Section chairs for their feedback. Dr. Birkett will ensure the draft of the technical document is distributed for review and comments.
